

Groningse Student Windsurf Association SurfAce

General conditions

1. These general terms and conditions apply to every member of the Groningen Student Windsurfing Association, actually established Blauwborgje 16, 9747 AC Groningen, registered in the trade register of the Chamber of Commerce for the Northern Netherlands under number 02066676, hereinafter also referred to as: association.
2. The association is represented by the board, as known to the Chamber of Commerce.
3. Every member of the association must be aware of the household regulations, the means of transport regulation, privacy policy, and the statutes of the association.
 - a. Each member must adhere to the documents referred to in Article 3.
 - b. These documents can be found on the site www.gswv-surface.nl or can be requested from the board of the association.
 - c. If the documents referred to in 3 are not properly complied with, the association is authorized to write off a fine.
 - i. Such a fine does not affect any further consequences described in these documents
 - ii. A fine can only be canceled by an absolute majority of the GMM
4. Each member must provide correct information to the secretary of the association.
 - a. Each member is obliged to notify the secretary in writing of changes to his/her personal data, which are collected by the association, within a period that can reasonably be determined.
5. Each member agrees with the ongoing agreement by accepting the terms and conditions, whereby the association is authorized to charge costs to the member. The member is also obliged to provide his/her bank account number when registering.
 - a. Costs are:
 - i. Membership fee as determined at the GMM
 - ii. Contribution for activities
 - iii. Contribution for rental of equipment, space, buses, and deposit
 - iv. Contribution for the use of buses
 - v. Fines
 - b. The authorization will remain in effect after the member has unsubscribed from the association, until all costs have been collected.
6. When registering with the association, the board determines which membership is given to the new member.
 - a. In addition to the membership types described in the articles of association, the board may also assign a spring membership and an intro membership.
 - i. The introductory membership runs from the KEI week up to December 1st. In this period the member is a full member. For this membership a reduced rate of €25,- applies. The introductory membership is automatically converted into a regular membership on December 1st unless the relevant member deregisters in writing with the secretary (or acting board member) before November 1st. The deregistration is only official with a confirmation from the secretary (or acting board member) of the association.
 - ii. The spring membership runs from April 1st until the KEI week. The member is a full member during this period. A reduced rate of €40,- applies for this

membership. Spring membership automatically gets converted into a regular membership during KEI week unless the member in question deregisters in writing with the secretary (or acting board member) before August 1st. The deregistration is only official with a confirmation from the secretary (or acting board member) of the association.

- b. All types of memberships of the association are tacitly extended until the next deregistration option, unless the member deregisters in writing with the secretary (or acting board member) before the latest deregistration date. Deregistration is only official upon confirmation from the secretary (or acting board member).
 - i. The latest deregistration date depends on the type of membership.
 1. Spring membership: July 31st
 2. Intro membership: October 31st
 3. Regular membership: July 31st
 4. Donor: August 30th
 5. Extraordinary donor: August 30
7. For questions/remarks, the board of the association can be contacted. The contact details can be found on the website <https://www.gswv-surface.nl/contact-en>.
8. The association offers windsurfing lessons for its members, but the association is not required to provide everyone with lessons. The member itself is responsible for registering the beginners lessons and full = full. The association is not liable for the member registering too late for the lessons. The member pays for the relevant membership costs as soon as the member has registered with the association, which means that in addition to fuel costs of the bus during the beginners lessons, the beginners lessons have no additional costs.
 - a. If a member cannot participate in the lessons, regardless of the cause, no compensation is applied for this.
 - b. A deposit of €20,- applies to the lessons. This deposit will be collected if the member has missed more than 1 lesson of the course in which he/she participated.
 - i. The number of lessons and the dates of a course are indicated on time, at uncertainty, the member him/herself is responsible for more clarity to inquire with the board.
 - ii. If a lesson is canceled, a new lesson will be scheduled. If the member is not present at this class, this absence also counts for the total absence.
 - iii. If the above conditions are not met, a joint decision of the BeginCie and the current board of the association, still lead to the return of the deposit.
9. If any clause from these conditions is destroyed, the other clauses of these terms and conditions remain in effect. In that case, the parties are expected to enter into consultation in order to convert a destructive clause into a valid clause, whereby the purpose and scope of the annulled clause must be taken into account as far as possible.
10. Dutch law applies to these conditions
 - a. In the event of a dispute, only the Dutch court has jurisdiction and the Judge with jurisdiction over the Northern Netherlands district.
